INFORMATION IN ACCORDANCE WITH GDPR 2016/679 (EUROPEAN GENERAL DATA PROTECTION REGULATION)

The data concerning you will be collected and processed by the Ce.Do.S.T.AF. Association: the owner and controller of the processing is the Association, in the person of its President.

The data will always be protected by adequate security systems, constantly updated and stored in a safe and controlled environment.

The data will be processed using computer and manual methods, in compliance with GDPR 2016/679, in order to manage the membership relationship and to promote and manage the activities of the Association.

Your data will be stored in the Association's archives for an indefinite period pursuant to Art. 17, paragraph 3, letter d of GDPR 2016/679 (even in the event that you lose your membership status), but may be deleted at any time upon your explicit request.

The provision of some data is mandatory and serves to ensure the correct basic management of your membership relationship: in particular, SURNAME, NAME and DATE OF BIRTH are essential for the correct and complete personal identification and the consequent attribution of the qualification of member, while the ADDRESS (complete with street, house number, ZIP code, Municipality, Province and any foreign country) is essential to deliver basic communications.

The provision of other data is optional and serves to optimize the relationship between you and the Association: in particular, the EMAIL ADDRESS is essential to quickly deliver all communications and newsletters, while the TELEPHONE number is useful to allow immediate contact in the event of social activities or initiatives that may directly concern you.

Any refusal to provide the data or a part of it could therefore result in the failure or partial execution of the association services offered.

The data will not be disclosed, but may be communicated to public authorities for the fulfillment of legal obligations, to banks for the management of collections and payments, to third-party entities and companies responsible for carrying out accounting, tax, contractual/associative relationship management and any disputes. The data may also be communicated for the same purposes for which they were collected to third-party entities or companies that, by virtue of the associative bond, provide products or services reserved for Members.

Pursuant to the aforementioned Privacy legislation, you have the right at any time to:

1. request access to your personal data, their rectification or their deletion;
2. obtain the limitation of the processing of your data or to oppose their processing;
3. withdraw consent to the processing of your data;
4. lodge a complaint with the Supervisory Authority.
